MLM'S COMMUNITY ASSISTANCE CENTERS PROVIDE FOOD, RENT AND UTILITY ASSISTANCE, LEGAL DOCUMENTS, HOUSEHOLD HYGIENE ITEMS, AND DIAPERS. MLM FOOD PANTRIES AVERAGE 100 CLIENTS PER DAY, RECEIVING FOOD FOR THEMSELVES AND THEIR FAMILIES. 2,833 HOUSEHOLDS RECEIVED FOOD FROM OUR PANTRIES THROUGHOUT THE YEAR, INCLUDING 367 OLDER ADULT HOUSEHOLDS, WHICH WERE PROVIDED WITH SENIOR COMMODITIES EACH MONTH. THE SATURDAY BREAKFAST MINISTRY PROVIDED 1,122 MEALS TO KANSAS AND MISSOURI INDIVIDUALS IN MIDTOWN KANSAS CITY, MISSOURI AND NORTHEAST KANSAS CITY, KANSAS. OVER 500 HOUSEHOLDS RECEIVED EMERGENCY RENT OR UTILITY ASSISTANCE, PREVENTING THEM FROM THE THREAT OF HOMELESSNESS.
